

# Ugo Vlaisavljević

## Curriculum vitae

Redovni profesor na Filozofskom fakultetu u Sarajevu, gdje predaje Ontologiju (Odsjek za filozofiju), Epistemologiju društvenih nauka (Odsjek za psihologiju), Sociologiju znanja i znanosti (Odsjek za sociologiju) i Književnost i naraciju identiteta (Odsjek za komparativnu književnost). Od 2003. godine predaje predmet "Ideja Evrope" na Evropskim studijama, a od 2005. „Rod i politika“ na Rodnim studijima pri Centru za interdisciplinarnе postdiplomske studije Univerziteta u Sarajevu. Glavni urednik filozofskog časopisa *Dijalog* (Sarajevo). Član redakcije međunarodnog časopisa *Transeuropeennes* (Paris). Predsjednik PEN centra BiH (2006-2009).

Objavio dvanaest knjiga, brojne članke i studije, od kojih nekoliko desetina u uglednim inozemnim časopisima i zbornicima (često izvorno pisane na engleskom i francuskom jeziku). Više puta bio gostujući profesor, te koristio stipendije i naučnoistraživačke boravke na uglednim univerzitetima u inozemstvu.

Učesnik brojnih međunarodnih skupova i konferencija, od kojih kao posebno značajno izdvaja svoju učešće na Prvom svjetskom kongresu fenomenologa održanog 1988. godine u Santiago de Composteli (Španjolska), gdje je bio član Naučnog odbora Kongresa uz neke od najpoznatijih filozofa današnjice (Derrida, Waldenfels, Ricoeur itd.).
